A Healthy Living Framework Supporting BC Seniors

With increases in life expectancy and declining fertility rates, Canada is experiencing population aging. While seniors currently comprise 12% of our population, this number is expected to double within the next 15 years – with greatest increases for "super seniors" 85 and older. The "graying of BC" proposes exciting opportunities for policy makers, communities and individuals as we strive to create a better province.

To formulate a seniors supportive action plan Health Canada has created a Seniors Healthy Living Secretariat located in the Ministry of Healthy Living and Sport. Their Healthy Living Framework emphasizes four cornerstones which require support:

- creating age friendly communities
- supporting older workers
- mobilizing and supporting volunteerism, and
- promoting healthy living.

Current Secretariat initiatives include the development of the BC Seniors Guide, Health lines Services BC providing 24 hour information and advice, and the creation of the Aging and Action grant program for volunteer organizations supporting seniors. How can you help?

Canadian Business leaders prefer giving to unique charities

Too many charities are trying to solicit for the same cause

According to a recent report, the leaders of Canada's largest corporations have very positive attitudes about the charitable sector - far more positive than either the broader business community or the general public. Almost 8 in 10 (79%) agreed that most businesses would donate to charity even without financial benefits, and 71% strongly agree that these organizations generally improve the quality of life in Canada. And yet, more than three-quarters (76%) said they face difficulties arising from increasing requests for donations, with 38% indicating that too many charities are trying to solicit money for the same cause. -- *Imagine Canada*

Presentation addresses future labour shortages in non-profit sector Slowing labour force growth will heighten competition

According to former **Canadian Policy Research Networks** vice president of research, **Ron Saunders**, a slowing labour force growth will heighten the competition among organizations for skilled workers. Saunders addressed the issue in a recent presentation to the "summit" convened by the **HR Council for the Voluntary and Non-Profit Sector**. In *Labour Force Trends and Implications for the Voluntary and Non-Profit Sector*, Saunders states that the voluntary and nonprofit sectors must identify strategies to attract and retain older workers and people from groups under-represented in the work force, including First Nations, immigrants and disabled workers. Saunders also notes recent research on job quality indicates that a sense of pride in the organization, particularly strong in the voluntary and nonprofit sector, is a key element in job satisfaction.

A new BC Bid Opportunity The Targeted Initiative for Older Workers

The Ministry of Advanced Education and Labour Market Development is proposing another BC Bid Opportunity—The Targeted Initiative for Older Workers. TIOW is a Canada-BC cost-shared program providing support to unemployed older workers. Specifically, seniors in eligible communities are targeted for employment reintegration programs. Projects will be coordinated by community-based organizations with expertise in employment programming.

Ideally, participating organizations will also have experience in addressing the special needs of older workers. Non-profits, businesses (including both Federal and Provincial crown corporations), public institutions, municipal governments and band/tribal councils are eligible to receive funding and act as project sponsors.

Deadline for all qualifying groups to submit proposals to act as Project Sponsors is March 31, 2009.

Stats Canada releases national donor statistics

Statistics Canada released new information about charitable donors in Canada last week, and you might find the results surprising. Over 2007, the number of charitable donors declined in Canada, but the donations made by Canadians actually went up. Last year, Canadian non-profits received \$8.6 billion in donations, up 1.4% from 2006. The number of donors, however, fell to 5.7 million, a 0.9% decrease. Although 24% of Canadians filing tax returns reported charitable donations, Statistics Canada suggests that the number may be higher since not all Canadians claim their donations on their income tax returns.

Imagine Canada releases report on corporate philanthropy New research study findings

A new research study from **Imagine Canada** finds that the community investment initiatives of many of Canada's largest corporations have moved beyond "chequebook philanthropy" and are leveraging their assets in more ways than the public—or even the charities and nonprofits they support—might think.

This focused research report, *Corporate Community Investment Practices, Motivations & Challenges: Findings from the Canada Survey of Business Contributions to Community*, puts a spotlight on 93 of Canada's largest companies (annual revenues exceeding \$25 million) and their community investment practices. It is based on findings derived from a broader study, *Canada Survey of Business Contributions to Community*, that looked more generally at business contributions to charities and nonprofit organizations in Canada.
