Tuberculosis in Kelowna

Interior Health would like to advise you of the increased numbers of tuberculosis cases in the Kelowna area, and new information on the Interior Health website to help keep the community up to date. From time to time your staff may come in contact with individuals who test positive for TB, and they may have concerns about possible exposure. However, TB transmission requires significant close contact with a person who has active tuberculosis.

Since May 2008 nine active cases of TB have been identified; more than would be expected based on historical rates. Most cases have been associated with a street-oriented lifestyle. However, an aggressive public health response has been put in place and health care workers are aware that they should be alert for people at risk for TB. In addition, Outreach Urban Health staff continues to share this information with numerous social service agencies.

Meeting the Needs of Young Parents

More than 1400 children are born to teenagers every year in BC. These vulnerable families often face overwhelming challenges, including homelessness, addiction, mental health difficulties, relationship and family violence, and social isolation.

In BC today there are 40 recognized young parent programs providing education, counseling, community referrals, and childcare for our province's struggling teenagers and their children. Through the BC Alliance for Young Parents, we are able to bring these dedicated professionals together, to share their experiences and challenges, exchange ideas, learn from new research and develop best practices. In October 2008, over 140 teachers, child care providers, program managers, youth workers, advocates and government representatives gathered in Victoria for Forging Futures, the annual conference for professionals working with young parents.

We asked conference participants where they feel the Alliance needs to focus in the future, and their responses are now collected in <u>Forging a Future for the BC Alliance for Young Parents (PDF)</u>. Among the survey findings:

- 62% identified advocacy work on behalf of Young Parent Programs as the most important focus for the Alliance
- 50% felt that professional development & networking was key to ongoing success
- 41% identified dissemination of information and research as valuable

Canadians Work/Life Conflict Needs Attention

Leading Canadian work-life expert Linda Duxbury, of Carleton University's Sprott School of Business, has released the sixth in a series of reports on the challenges faced by working families in Canada. She's calling on government and policy-makers to pay more attention to the needs of families. The time has come, she says, for employers and government to recognize that "workers are family members and family members are workers."

The study was commissioned by Health Canada and surveyed workers in 100 major organizations in the private, public and not-for-profit sectors, and found that:

- 60% of working Canadians can't balance work/family—work is taking priority over family time
- in 1991: 1 in 10 Canadians worked more than 50 hours per week
- today: 1 in 4 Canadians work more that 50 hours per week
- 1 in 4 study participants reported that work interferes with their family responsibilities

The report poses important questions about Canadians' values when it comes to families and work: "Why is caring for our seniors and our children causing so much strain? Why are Canadian men and women foregoing having families or reducing the number of children they have? Are we asking too much of families?" More Services Needed for Homeless Aboriginal Youth - British Columbia

A new report has provided a detailed analysis of the experiences of marginalized and street involved Aboriginal youth in British Columbia. The report includes the response to the findings from Aboriginal community members, and calls for increased services. The most common services young people said they needed was safe and affordable housing, job training and work experience.



Some of the statistics included in this report:

- Over 40 per cent had first run away at age 12 or younger
- One in three had been kicked out by age 12
- 47 per cent had gone hungry because they or their parents didn't have money for food
- 63 per cent reported having witnessed family violence
- Almost 60 per cent having been physically abused
- One in four reported experiencing racial discrimination in the past year.

Community Food systems Assessment Guide for British Columbia

Community food system assessments (CFSA) should involve a full range of participants, including producers, distributors, and consumers within the community as well as academic and applied researchers, students, and service providers. This range of perspectives and expertise allows for a comprehensive view of the food system and encourages support for the findings and recommendations of the assessment.

Community food assessments can have many purposes, depending on how they are focused and who the audience is. Some of the main benefits of a CFSA are:

- to provide a comprehensive picture of the current state of the food system;
- to provide a framework for understanding how different components of the food system act together to contribute to the health and well being of the community;
- to provide compelling information that can inform decision-making, public policy, and funding with reference to the food system;
- to improve program development and coordination;
- to increase community awareness of and participation in food-related projects;
- to ensure that projects enhance food security;
- to help articulate a vision of what needs to be done in the community;
- to help set priorities and goals to improve the local food system;
- to identify potential partners, community resources, and opportunities;
- to build new and stronger networks, partnerships, and coalitions;
- to provide data that can be used in future proposals and reports;
- to establish a long-term monitoring system with a clear set of indicators;
- to generate information for funders, including community food security funders, who are increasingly requiring evidence-based research to substantiate proposal requests.

#### **Economic Downturn is Leading to More Family Violence**

CALGARY – Some experts say the economic downturn is leading to more family violence and driving an increasing number of Albertans to seek counseling. The Calgary Counselling Centre said it is dealing with the heaviest caseload ever and that the statistics have been getting worse since the stock market meltdown began last fall.

Spokeswoman Kathleen Bell said that since September, requests for services have jumped by about 21 percent while family violence cases at the centre have doubled over the past year. She said clients are talking about economic stressors and an overwhelming fear of the unknown. People want help with their relationships and depression.

The Distress Centre Calgary said it hadn't notice an increase in calls, but the pleas for help they are getting are more dire. Spokeswoman Michelle Wickerson said some clients who moved to Calgary have become disillusioned with their adopted city. "It's very telling – it's about evictions, disconnections of utilities, circumstances where they've exhausted all other alternative," said Wickerson. "People who've moved here have told us they were better off back home."

#### **Federal Government Releases 2009 Budget**

The federal government released their highly anticipated 2009 budget on January 27, 2009. The budget highlights mainly focus on the worsening economy in the form of stimulus spending, personal income tax relief, and an extension of Employment Insurance benefits. Although no announcements were made in relation to **Imagine Canada**'s proposal for assisting the voluntary sector, there were some announcements that will affect nonprofits throughout Canada.

- \$2 billion for social housing for low-income earners, seniors, people with disabilities and native Canadians
- \$2 billion to repair post-secondary institutions
- \$325 million to Aboriginal organizations and provinces to deliver health programs and child and family services
- \$60 million over two years for community theatres, libraries and museums
- \$75 million over two years for Parks Canada facilities, and an additional \$75 million for national historic sites

#### **Budget 2009 Receives Tepid Response from Voluntary Sector**

"There was extreme disappointment."

Those were the words used by **Teri Kirk**, VP public policy & regulatory affairs with <u>Imagine Canada</u>, in describing her organization's reaction to last week's budget throne speech. And that was the sentiment

shared by many in the voluntary sector after the Conservative government threw out the numbers for its "stimulus package" to the nation.

Kirk said Imagine and its scores of sector partners - including such notable organizations as <u>United Way Canada</u>, <u>Salvation Army Canada</u>, the <u>Muttart Foundation</u>, <u>YMCA Canada</u>, and the <u>Boys and Girls Clubs of Canada</u> - had been in consultation with the government to try and impress upon it the great need for economic stimulus. "We can be a partner [to the government] during difficult economic times. We had expected that the government would recognize this. An economic downturn of this nature [spikes] demand for charitable services," Kirk said. "We called on the government to hold the line on grants and contributions, that this was not a time to make cuts, that it was a time to encourage Canadians to give...we asked for assurances of that nature and didn't get them."

Once the actual budget was revealed, Kirk said Imagine Canada became "concerned" about the sector maintaining services, let alone increasing them for the swell of people who may need them during this recession.

#### **Online Users Good at Multitasking**

Canadians are spending almost half of their online time multitasking, listening to music or watching television while using the Internet. Canadians spend on average 15 hours per week online, 15 hours per week watching television, 10 hours per week listening to the radio, and only 3 hours, or 30 minutes per day, reading newspapers. For younger users, the Internet is rapidly outpacing television as their primary recreational activity, with those aged 18 - 34 spending 18.4 hours online each week, while those aged 35 - 54 spend 13.6 hours online and those 55 and older spending 14.2 hours online. -- *Ipsos Reid*

#### **Not-For-Profit Corporations Act Reintroduced in Parliament**

On January 28, 2009, the *Canada Not-For-Profit Corporations Act* was reintroduced by the Honourable **Diane Ablonczy**, Minister of State (Small Business and Tourism). The bill was introduced in the last session of Parliament but died when Parliament was prorogued on December 3, 2008. The proposed act will enable organizations to incorporate faster and improve their financial accountability, clarify the roles and responsibilities of directors and officers, and enhance the protection of members' rights. It will also allow for the repeal of the outdated *Canada Corporations Act*. Corporations currently incorporated under the *Canada Corporations Act* will have three years to apply for corporate status under the proposed *Canada Not-for-Profit Corporations Act*. There will be no fees for this process.

#### **New Report Examines Nonprofit Fraud and its Consequences**

Nearly 70% of insiders who defraud nonprofits face jail time, according to new research released by the **CA-Queen's Centre for Governance**. The study found that the average fraud cost to a nonprofit is \$119,821 per occurrence and was more likely to occur in large urban centres than in smaller centres. More that 90% of reported frauds of nonprofits are committed by one person, with the most frequently reported fraudsters holding senior management positions. CEO-committed frauds cost nonprofits the most, at \$176,000, while fundraiser fraud averaged \$60,000. Age is highly correlated with fraud with board members, management and employees who are older or longer serving more likely to commit fraud. However, when younger employees do commit fraud it is for large amounts (average of \$868,667).

#### **Preventing Youth Suicide in BC Communities**

In December 2008 the Child Death Review Unit of the BC Coroners Service published a 5-year retrospective review of child and youth suicide. The report's 17 recommendations reinforce the need for child-serving agencies to find ways to work collaboratively with youth and families of diverse cultures and traditions in order to prevent suicides in our communities.

Two recommendations focus on the critical need for planned, organized, community-wide approaches to dealing with youth suicides. Known as **postvention**, these coordinated community action plans outline the activities that should take place after a suicide and identify the roles and responsibilities of different community agencies and groups. Postvention plans are proven to reduce the risk of further suicides occurring, and to facilitate healthy expressions of grief.

#### **Human Resources Q & A**

**The question:** Do you have any suggestions for new supervisors who need to quickly bone up on management?

**Tim's response:** You know what I like about this question? The person posing it recognizes that people who are new to supervision/management are entering a work discipline unlike anything they've ever done. That means that they need to learn about things that they previously didn't have to know, and also learn how to do things that previous workplace roles didn't require of them.

There's lots and lots of information out there on the subject of management. There are books, digital books, articles, monographs, courses, DVDs, speeches and CDs. You may not need any other information source on management.

#### New Report Suggests Food Banks are Expected to do too Much

A Saskatchewan report released by the Canadian Centre for Policy Alternatives calls on government and policy makers to address poverty issues. *Bridging the gap from poverty to independence: What is the role of the Canadian Food Banks?*, written by Candace Weimer, examines the role of food banks in Canadian society, concluding that they should continue to solely be emergency crisis centres, as they were initially intended. Weimer explores various anti-poverty measures in other countries, as well as current initiatives in Canada, and suggests that the public is better served when food banks aren't forced to expand their services to address all poverty issues.

#### Starving Artist Stereotype Rings True in Canada

According to a recent study, artists in Canada are, on average, living right at the poverty line and are unlikely to see their situations improve in the current economic climate. Canadian artists earn 37% less than the average working Canadian, bringing in only \$22,731 in 2005. Of the artists surveyed, 43% made less than \$10,000. Salaries seem to be decreasing as well, as artists in 2005 made 11% less than they did in 1990. Most artists seem to find other work to help them get by, with 42% indicating they had a secondary part-time job in 2005. -- Hill Strategies Research

#### **Poverty Tied to Bad Health According to Ontario Report**

Chronic and severe health conditions hit poor Ontarians at rates that are far higher than those of average Ontarians, according to new research. Diabetes, heart disease, chronic bronchitis and mood disorders are found at rates as much as 4.5 times higher among social assistance recipients than those not on social assistance, according to the study by the Community Social Planning Council of Toronto, the University of Toronto's Social Assistance in the New Economy Project, and the Wellesley Institute.

The study, entitled Sick and Tired: The Compromised Health of Social Assistance Recipients and the Working Poor in Ontario, examined health and income data from across the province and found that

people on social assistance had worse health on 38 of 39 indicators when compared with the non-poor. Suicide attempts were 10 times higher for social assistance recipients compared to the non-poor.

#### **Workplace Conflicts Can be Positive When Properly Managed**

According to a new survey of Canadian human resource managers, 81% saw workplace conflict lead to someone leaving an organization, 77% saw it result in sick leave or absences, 76% saw it cause personal insults, and 43% saw it result in someone being fired.

However, these HR managers also acknowledged the positive aspects of properly managed conflict, with 77% saying it results in a better understanding of others, 57% that it results in better solutions to problems, 40% saying it boosted team performance, and 21% indicating it led to major innovation. While 90% believe that handling workplace conflict is an important skill, only 64% said they believe current management at their organization is skilled in working with conflict. -- *Psychometrics Canada Ltd.*

#### **US Corporations Still Planning on Giving Even in Economic Downturn**

According to a recent survey of US corporations, 42% of corporations and 37% of corporate foundations indicated that their giving budgets will decrease in 2009. However, the size of the decrease appears to be small, at only 3 - 5%. Half of the corporations responding to the survey said their giving budgets will stay the same in 2009. Corporate giving does appear to be changing with the changing economy, with 49% of those who were supporting arts and culture indicating they will decrease their gifts to that sector, and increase gifts to nonprofits dealing with basic needs and environmental causes. Many are also shifting to giving locally, with 84% indicating they will be more strategic with their donations. -- LBG Research Institute

No reasons for the decision were given. Charities must comply with *Do Not Call List* regulations, which include registering with the Do Not Call operator, paying the appropriate fees to the *Do Not Call List* investigator, and maintaining a private do not call list within their own records.
