The Mobile Garden Project

The groundhog has spoken, it will soon be the gardening season and it is time to think about our mobile school/community gardens. This year our project is expanding to two elementary schools on the Westside and we are looking for your support.

Sponsorship in 2017 was provided by The Telus Ambassadors (major financial contribution for wagons), Crowe McKay (financial for soil), Independent Foods (soil, seeds, stakes, plants and watering cans) Princess Auto (significantly discounted wagon purchases), Art Knapp (seeds),

Katelin Mitchell (manure) and The City of Kelowna (fertilizer).

Vision

The initial vision of the group at Pearson Road was to develop a garden to serve the school and community. A place to create educational opportunities especially in science and literacy. A place to provide opportunities for leadership and sustainability. The vision is one of generations and cultures working together in a hands-on way, creating a community space with chairs and a meeting area. The group would like to see a space currently used partially for bike storage be repurposed to develop the garden. The garden space is an unloved piece of land, which is right at the front of the school.

Paintings go up at Airport

Julie Oakes: Awestruck, Calendar of Ecology February 19 – August 13, 2018

Passengers at the Kelowna International Airport may notice something different this week as they approach the security gates in the departures area.

A series of large paintings by Vernon-based artist Julie Oakes have been installed in the fortyfoot-long satellite exhibition space that the Kelowna Art Gallery curates. The installation is entitled Awestruck, Calendar of Ecology, and the four works that comprise it each depict a season of the year, with flora and fauna that are native to the Okanagan.

For example, viewers examining one of the pieces, Winter, will notice a snowy landscape strewn with familiar trees, shrubs, flowers, and animals backed by a nighttime sky lit by a full moon. What distinguishes this work from a straight-forward pastoral winter scene, can be glimpsed in the glassy-eyed stares of the animals. They are a little unsettling, which just might be what the artist intended.

Oakes is interested in exploring themes of the spirituality found in nature. The animal subjects are given the reverence of saints — fur perfect and eyes bejeweled, which also seems to reflect an ideal of nature rather than the real, messy and unpredictable "otherness" of the animal kingdom. Data on Charitable Donors

Total donations reported by Canadian tax filers fell to \$8.9 billion in 2016, down 2.7% from 2015.

The largest decreases were in Alberta (-10.7%), Prince Edward Island (-5.3%), Nunavut (-4.4%) and Saskatchewan (-4.1%). Yukon (+4.5%) had the largest increase in donations in 2015.

The decrease in total donations (-10.7%) in Alberta for 2016 may be associated with economic factors in that province such as the decline in resource prices. For the previous three years, Alberta had an annual increase in the dollar amounts of donations, which was close to or above the national average. Even with this decrease in 2016, Alberta still had a higher proportion of tax filers making donations (21.1%) than the national average (20.5%). It also still had the second highest median donations at \$470, compared with the national median donation of \$300.

Encouraging Culture Awareness Among Volunteers

The following quick tip is excerpted from the book The A-Z of Volunteering and Asylum by Ruth Wilson, published in 2003 by The National Centre for Volunteering (England).

'Culture' is a shared set of knowledge, beliefs, customs, morals and habits. Many of us are unaware of our culture, because we grow up in it and consider it normal – though if we are members of a minority group we may have been pushed into being culturally aware through being made to feel 'different'...

It is both enriching and beneficial to learn about different cultures. Volunteer managers can work to help staff and volunteers be aware of both their own and other people's cultures – this can also help if friction occurs because of different cultural norms or because of misunderstanding.

It is important to remember that people brought up within the same culture may perceive that culture differently. No culture is static, all cultures change, and cultural identity is only one of the many influences that make us who we are. For instance, our ethnicity, immigration personal philosophy are all part of our makeup, and some of these may mean more to us than culture.

So, while learning about culture is important, it is equally important to avoid stereotyping. Alongside giving staff and volunteers information about particular cultures or nations, you need to help them build up self-awareness and the skills to ask the right questions, to listen well, and to be sensitive when working with people from different backgrounds.

[Start with the following checklist, compiled by Judith Schott and Alix Henley, in their book Culture, Religion and Childbearing in a Multiracial Society, published by Butterworth Heinemann, 1996.] Checklist – Cultural Awareness

- Be aware of your own cultural assumptions and how these may affect your understanding and responses
- Listen with respect and a genuine wish to learn
- Find out how people see themselves and their culture, what they value, what they see as important
- Beware of negative or pejorative 'information' it usually indicates prejudice or incomplete understanding
- Understand that in discussing culture we are discussing possibilities, not certainties a framework, not a straitjacket
- Be prepared to change your understanding as new information becomes available
- Sort out what information is useful and helpful to your work, and what is merely exotic or personally fascinating
- Understand the importance of factors such as age, generation, life experience, occupation, education and so on
- Realise that culture is one factor, but not the only factor in anybody's life remember that the person you are working with is always the expert on their own life, wishes and needs

Is Volunteer Management Really a Profession?

I've been in the field of volunteer administration for over 25 years and have seen many changes-most are positive ones. But some questions are still unanswered, particularly whether or not we can identify our work as a "profession."

Too many of us still "fall" into volunteer management positions, either as a stepping stone towards another career goal or by the unexpected addition of the tasks of volunteer program development to existing job descriptions. Some of us then discover we really love this work and have an affinity for it. We wind up making a long-term commitment to volunteerism. But at any given time, our field is dominated by people who view volunteer management as a job and not as a career–certainly not as an identity. They will move on (and often up) as soon as a better job opens to them.
