Inn From the Cold – Chandler Street Housing Project

Inn from the Cold is a registered charity dedicated to addressing the issue of homelessness within its community of Kelowna, BC. Our mission is to respond to the needs of people who are experiencing, or are at risk of homelessness, in a welcoming, compassionate and mutually respectful manner.

Our most recent project – The Chandler Street Housing Project – is a house which will provide 8 men experiencing chronic homelessness in Kelowna, BC permanent housing in an effort to increase mental and physical health within our community.

Recently, we have run into some unexpected setbacks in regards to the renovations of our 1829 Chandler Street building and in order to get the house up and running we need the community's support.

What We Need

In order to reach city requirements and obtain our occupancy permit, we need \$15,000. This money will be put towards:

- Building renovations Materials (drywall, t-bar) and labor (installation of t-bar and drywall, electrical) in order to meet fire retardant codes
- Operating costs
 Rent, utilities, staff wages

What You Get

- Corporate Social Responsibility improve your image within the community and have your logo or name added to our website
- Tax receipt and credit for your donation

The Impact

According to last year's homeless consensus, there are about 400 people residing in Kelowna who do not have a permanent place to live. In the State of Homelessness in Canada report released in 2013, it was found that only 15-18% of shelter and homeless service users were experiencing chronic homelessness. This means that by targeting this vulnerable sub-population for housing, we can make a significant impact on chronic homelessness in Kelowna.

We will be basing our program around the Housing First philosophy—which promotes the idea that providing housing is the first step to transitioning out of homelessness, not the last. This approach uses principals such as a low-barrier, (no "housing-readiness" requirements) solution to housing with personalized care plans focusing on holistic recovery rather than

simply "sobriety". We aim to provide physical and mental support for these individuals in hopes of creating a healthier community in the long-term.



Results of the 2014 Homeless Count in the Metro Vancouver Region

This report presents the results of the 2014 Homeless Count in the Metro Vancouver region that took place on the evening of March 11 and the day of March 12, 2014. It provides information about people who were identified as homeless during this 24 hour period and compares the results with previous Homeless Counts where possible.

Some of the findings:

- A total of 2,777 homeless people were counted in the Metro Vancouver region. This included 2,689 adults and unaccompanied youth (under the age of 25) as well as 88 children (under the age of 19) who were accompanied by a parent during the count.
- The number of homeless people identified in Homeless Counts in the region has remained fairly stable since 2008 – increasing by 4% between 2008 and 2014.



- Emergency shelters, safe houses and transition houses reported 317 turnaways, including adults, youth and children.
- 582 homeless people identified as an Aboriginal person during the count, representing about one third of the total homeless population in the Metro Vancouver region. Aboriginal Peoples are over-represented in the region's homeless population given they represent 2% of Metro Vancouver's population.

Housing First in Rural Canada: Rural Homelessness & Housing First Feasibility Across 22 Canadian Communities

Critical Time Intervention Training

This half-day training is targeted to service providers working with persons transitioning from homelessness or other institutions to the community. Critical Time Intervention (CTI) is a cost-effective, evidence-based practice designed to prevent recurrent homelessness, recidivism, and other adverse out comes during the period following placement into the community from shelters, hospitals and other institutions. This time-limited intervention is delivered in three phases, each usually lasting three months. Each phase decreases in service intensity and results with the intervention ensuring the participant is linked to the appropriate community services to ensure housing and life stability. The training includes an overview of CTI and reviews the specific treatment areas supported by this intervention and is appropriate for individual and family practitioners.

1.4 Medicaid 101: The Basics for Homeless Advocates

Some vulnerable adults and children may be newly eligible for Medicaid services. This session will outline Medicaid eligibility and benefits and the intersections with other low-income health care programs. Presenters will also provide a foundation for understanding how Medicaid services are reimbursed.

Housing For All: Sustaining and Renewing Social Housing for Low-Income Households

Housing For All: Sustaining and Renewing Social Housing for Low-Income Households ushers in a new plan for the revitalization of social housing in Canada, in the wake of expiring federal funding through operating agreements. The Report proposes to do things differently – to build an efficient, self-sustaining and innovative system of social housing in Canada. Three broad recommendations are articulated; two new investment streams, for affordability and for capital repairs, to be designed and delivered by the provincial/territorial governments through a negotiated cost-sharing framework with the federal government, and a third recommendation enabling a transformation of the social housing sector.

Realizing Our Potential: Ontario's Poverty Reduction Strategy (2014-2019)

In 2008, Ontario released its first Poverty Reduction Strategy, Breaking the Cycle, which set a target of reducing child poverty by 25%. Although the target was not met, 47,000 children and their families were able to exit poverty. The new plan builds on the progress made and sets out to continue to break the cycle of poverty.

Ontario is setting a new goal of ending homelessness. Research will be used to help define the problem, measure it and set targets. Lessons learned and best practices related to housing and homelessness from different communities will be used to inform progress. The report cites that investments in homelessness prevention will be made, which would include expanding access to supportive housing, and more investment in affordable housing. An annual report of progress will also be made available.

Free Legal Advice-a-Thon

On September 5 (Vancouver), September 9 (Surrey), September 12 (Victoria), September 16 (Kelowna) and September 17 (Kamloops) over 100 volunteer lawyers will participate in the annual free legal advice-a-thon to raise awareness and funds for the provision of pro bono legal services in BC. All funds raised will go directly toward supporting the pro bono programs operated by Access Pro Bono.

In each free legal advice-a-thon location, volunteer lawyers will work in one-hour shifts throughout the day to advise individual clients in an open-air setting. Mandatory Fingerprinting proposal by RCMP

AVRBC has learned the RCMP has proposed making it mandatory that all applicants applying for police records checks also be fingerprinted. This is a policy that would be put into effect as of July 2016.

This new policy would affect:

- Volunteers being checked by RCMP detachment or local police
- Volunteers being checked by the procedures of provincial government departments (such as the procedure of the security certificate online from the Department of Justice of British Columbia)

The Edmonton Police Service has raised concerns about the new policy that were published in the Edmonton Sun.

On September 9th, there will be a National Dialogue on Screening Volunteers organized by Volunteer Canada. Decision-makers from the RCMP and Public Safety Canada will be there. A member of the <u>Volunteer Management Professionals of Canada</u> (our national professional organization with which we are affiliated) and Stacy Ashton, AVRBC member, will be in attendance and participating in this dialogue.
